

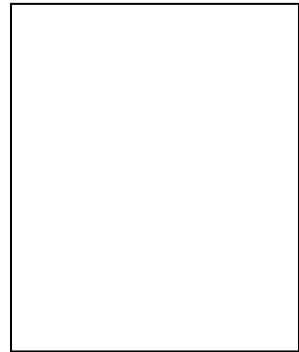

NOTE:

1. The Proposer and the first Seconder has to be a member of the High Court Bar Association and not less than ten years standing.
2. The other four **Seconders** must also be members of H.C.B.A. with not less than five years standing.
3. Attach Attested copies of residential address (i.e. copy of Ration Card, Passport, Election Card etc.)
4. One photograph should be affixed on the application form.
5. Application form must be accompanied with the Photocopy of Bar Council Certificate and L.L.B. Degree. If the applicant is a member of any Bar Association, the certificate of that particular Bar Association should also be attached. No application form will be accepted without the above documents.
6. Applicant applying for the membership of the H.C.B.A. must attend the meeting of the Membership Committee. Failure to do so for three consecutive meeting, his/ her application will be rejected and he/ she will be debarred to become a member of H.C.B.A.
7. On confirmation of the minutes of the membership Sub- Committee by the Executive Committee the applicant will be granted/ I Card of the H.C.B.A. and the member will also have to deposit Rs. 1500/- as admission which has been made compulsory for all H.C.B.A. members.

8. Applicant shall be present in person before the Secretary High Court Bar Association at the time of making his/her signature at the time of submitting membership form.
9. All Cheques/ Demand Drafts should be drawn in favour of “High Court Bar Association”.
10. For outstation cheques kindly add Rs. 30/- as Bank charges.
11. If Chamber address written in the form the authority letter from the Chamber allottee be attached.
